In addition, by payment of a deposit, and/or my signature on this form, Artist certifies that he/she is over eighteen (18) years of age and will abide by all terms as stated herein. Artist hereby agrees this release shall be binding upon and enforceable against Artist, Artist’s personal representatives, spouse, assigns, heirs, successor, and agents without limitation.
